#### **SCOPE OF THE WORK**

Printing of fictitious enrolment numbers/centre numbers on pre-printed OMR award sheet and adhesive stickers for Secondary, Sr. Secondary and Vocational examinations on continuous form of stationary which will be provided by NIOS Eligibility Criteria

- 1. The Computer agency must be registered under Company Law & required to have minimum three years experiences of doing Admission & examination work.
- 2. The agency must have three years experience in similar type of work at least in anyone of the examination Boards/Universities/Educational Institution of repute. Certificate from the various organizations where services rendered needs to be enclosed.
- 3. The agency must not be blacklisted from any Govt./Semi Govt. organization in the last three years .
- 4. The minimum turnover of the Agency must not be below Rs. 10,00,000/- (Rupees Ten Lakh only) in the last 3 years.

#### **Terms & Conditions**

The agency shall be deemed to be agreeable to the terms and conditions herein contained. Responding to these terms and conditions shall be binding on the successful Agency. Agency complying partly are liable to be rejected. National Institute of Open Schooling (NIOS), Noida, will process the tender as per GFR-2017 the standard procedures followed by NIOS. NIOS reserves the right to reject any or all or part of tender without assigning any reason whatsoever and shall also not be bound to accept the lowest tender. NIOS will not under any obligation to give any clarification to the agencies whose bids are rejected / not selected.

- 1. The tender must be submitted in the prescribed format only.
- 2. While submitting the tender, the agency must submit Tender Document and the <u>Financial Bid</u> on the prescribed format.
- 3. The sealed envelope of "Technical Bid" and "Financial Bid" should be sealed by the bidders separately in envelops super scribing "Technical Bid" or "Financial Bid" as the case may be for printing of fictitious enrolment number/centre number on pre-printed OMR award Sheet and adhesive stickers. Both these sealed covers are to be put in a bigger cover which should also be sealed & superscribed. The Technical Bid must be accompanied with EMD and other relevant documents duly singed by the Tenderer with rubber stamp.

# 4. All the pages of the tender documents are required to be signed by the Head of the agency or by the authorized signatory along with seal of the firm and date.

- 5. Sealed tender should be submitted either personally or send through registered post addressed to the Director (Eval), National Institute of Open Schooling,A-24/25, Institutional Area, Sector-62, Noida (U.P.)-201309, superscribed in bold letters <u>Sealed</u> <u>tender</u> to be opened by the addresses on the date & time of the opening of the tender which should reach NIOS by the scheduled date and time. The Tender received after the due date and time will summarily be rejected.
- 6. The Technical bid shall be opened at the first instance and evaluated by a committee duly appointed in this behalf. NIOS shall not responsible for accidental opening of the covers that are not properly super scribed and sealed before the time notified for opening of the tenders.
- 7. The Tender will be opened in the presence of representative who wish to be present at NIOS, NOIDA with authorization letters from the respective agency

- 8. At the second stage financial bids of only those technically acceptable offers shall be opened after intimating the bidders the date & time of opening of financial bids for further evaluation & ranking. No revision of the rates will be allowed once the tender are opened. These rates will be valid for one year and may be extended further for another two years subject to satisfactory execution of the said work at same rates, terms and conditions on year to year basis. The rates of printing the enrolment number on OMR award sheet and adhesive stickers per subject/per record will be all inclusive and no extra payment shall be admissible. Extension of the said contract shall be at the sole discretion of the NIOS.
- 9. NIOS will provide the requisite quantities of Blank OMR award list and adhesive sticker thereafter the agency will be responsible for the printing work strictly as per specification of NIOS.
- 10 The agency will have to complete the work strictly as per the guidelines and schedule given by NIOS.
- 11. All the stationery of the printing work shall be provided by NIOS. The agency shall be required to undertake full responsibility, safe custody and maintain confidentiality in the whole process of the work.
- 12. The Earnest Money Deposit (EMD) is to be enclosed alongwith the Technical bid of the tender in shape of Demand Draft drawn on any Nationalized Bank in favour of Secretary, National Institute of Open Schooling, payable at Noida, U.P. failing which the tender shall be rejected outrightly.
- 13. The successful agency shall have to submit bank guarantee/demand-draft in favour of Secretary, NIOS, Noida amounting to 10% of the total annual value of work toward security deposit. The Security is liable to be forfeited in case the agency fails to execute the order in time, quality of the work or violate any other stipulations as laid down by the NIOS. The Security deposit/Bank Guarantee shall have to be renewed by the agency in case extension of services is agreed upon. Suitable penalty may be imposed and the agency may be black listed.
- 14. The EMD amount will be returned to the unsuccessful agency without any interest after completion of selection process and receipt of security deposit from the successful bidder.
- 15. The rate should be quoted for printing of enrolment numbers on pre printed OMR award Sheet and adhesive stickers per subject/record basis only as per the specifications which should include all charges (all inclusive).
- 16. The agency must have minimum three years of experience in computerization of admission and examination work at least in anyone of the examination Boards/Universities/Educational Institution of repute.
- 17. The agency must not have been black listed earlier by any of the Universities or Examination boards or any other Govt. or Public Sector Organization.
- 18. To protect the highly confidential nature of this job, assigning the job in full or part to any other agency/firm shall not be allowed. The agency should have complete in-house facilities for the entire processes of work.
- 19. Payments will be made only after satisfactory & successful completion of the printing work and upon submission of bills subject to TDS as applicable. No advance will be paid to carry out the work.
- 20. NIOS, having HQ at NOIDA, reserves the right to change the ordered quantity or specifications without assigning any reason(s) whatsoever.

- 21. The National Institute of Open Schooling (NIOS), NOIDA, has the power either to accept or to reject the tender wholly or partially without assigning any reason and the decision of the Secretary, NIOS, NOIDA, (U.P) will be final and binding in this regard.
- 22 The entire work intended to be tendered is of confidential in nature. Hence absolute accuracy and confidentiality required to be maintained.
- 23. Rates should be quoted both in the figures and words.
- 24. In the event of rates being accepted, the tender will be converted into a contract. The rates will be valid for one year and shall be extendable for another two years on the same terms and condition and rate subject to satisfactory execution of the work on year to year basis at sole discretion of NIOS.
- 25. If the selected agency fails to complete the job and NIOS is constrained to get it done through any other agency at higher rates, the difference in the rates shall be deducted from the agency bill/securities besides forfeiting the security deposit of the agency, imposing penalty and taking such other action as may be deemed fit by the NIOS.
- 26. If the agency refuses to execute the job after accepting the offer at any point of time during the contract period, the security deposit will be forfeited in full or in part which is at the sole discretion of the NIOS. Further any action as deemed fit will also be taken.
- 27. In the event of any dispute arising between the NIOS and the selected agency, the same shall be subject to the jurisdiction of courts in Delhi.

#### **Penalty Clause**

As this work is a very sensitive/confidential in nature, complete confidentiality may be ensured in execution of the whole work. Secondly, in case the agency is unable to complete the assigned printing work within the stipulated time and the quality of printing is not maintained, a penalty up to 10 % of total cost and or as decided by the NIOS Competent Authority may be imposed on the agency. The work order may also be cancelled and the agency may be black listed.

#### **Arbitration Clause**

- 1. In the event of any doubt arising in the interpretation of provisions, practices and rules, the decision of the Chairman, NIOS will be final and binding to all.
- 2. Any disputes arising out of the application of these provisions, practices and rules or matters arising out of them will be subject to the jurisdiction of Court in Delhi.
