In pursuance of the recommendations of the 15<sup>th</sup> Academic Council held on 24<sup>th</sup> Dec, 2013 and subsequent approval of the 66<sup>th</sup> Executive Board of NIOS held on 19<sup>th</sup> June, 2014 in connection with implementation of internal assessment in NIOS Public Examinations, the following guidelines have to be adopted/implemented.

Internal Assessment (IA) including Tutor Marked Assessment (TMA) in Secondary and Senior Secondary Examinations will carry 20% weightage in the External Examination and the marks will be shown separately and added to the marks obtained in the External Theory Examination and Practicals (wherever applicable). The policy for implementation of the Internal Assessment shall be as per details given below.

#### 1. WEIGHTAGE OF INTERNAL ASSESSMENT

Weightage of IA shall be 20% of Theory Marks including TMA and other academic activities as per details given below:

#### 3. SUBMISSION OF TMA BY LEARNERS

Submission of Internal Assessment including TMA etc. will not be compulsory for declaration of results. The NIOS has made earnest efforts to popularize the scheme amongst the Study Centres and learners, highlighting its merits, so that learners are encouraged to submit the TMA.

#### 4. SCHEDULE OF SUBMISSION OF TMA

- 1. All TMA are required to be submitted by learners at the allotted Study Centre (AI). Evaluation has to be made by the staff of Study Centre (AI).
- 2. In case Study Centre (AI) is non functional, TMA has to be submitted at the concerned Regional Centre and the same be got evaluated by RC.
- 3. In case any Study Centre (AI) is closed because of some reason, TMA will be submitted at the Study Centre where learners have been shifted. Evaluation will also be done by the same Study Centre (AI).

#### 5. AVAILABILITY OF TMA

There will be only one TMA in every subject, which includes all kinds of questions – very short answer, short answer, long answer and project based. An attempt has been made to make the questions more application based. Academic Department will prepares two booklets of TMA in all subjects – one each for Secondary and Senior Secondary. The TMA will also be uploaded on NIOS website from where learners can download them.

### 6. MODE OF SUBMISSION OF INTERNAL ASSESSMENT(IA) AWARDS

- i. Als will submit the Internal Assessment (IA) marks to its respective Regional Centre.
- ii. Als will make available an interface on NIOS website.
- iii. Once the data is entered, the details of learners allotted to the AI will be displayed.
- iv. This interface will also be having details of the subjects opted along with space for submission of IA marks.
- v. Once the marks are submitted, option to verify the marks will be provided.
- vi. Once the AI certifies that marks submitted are correct as per IA record, data will be submitted and print outs will also be taken/generated. One copy will be for Study Centre (AI) and another for concerned RC. The Regional Centre copy will be dispatched in such a manner that the same reaches the concerned RC latest by 15<sup>th</sup> March/ 10<sup>th</sup> September for Block-I & II Admission for April-May and October-November Public Examination respectively.
- vii. On receipt of hard copy at RC, details will be updated by entering date of receipt of awards at RC on web itself.



#### 7. THEORY EXAMINATION

The Maximum Marks of Question Paper for the External Examination will remain as before; the marks obtained will be proportionately reduced to adjust the Internal Assessment marks. This is the reason that the Question Paper is the same for Stream II, where there is no IA. The table mentioned below shows the Maximum Marks in various subjects:
