3. TERMS AND CONDITIONS:

- 1. The disposal of the waste materials would be on "As is where is basis".
- 2. Earnest Money Deposit of Rs.3,00000/- (Rupees Three Lakhs Only) lump sum in the form of Demand Draft in favour of "Secretary, NIOS, payable at Kolkata" shall be required to be deposited along with the technical bid of tender appended at Annexure-I. A tender received without EMD shall be rejected as non-responsive at the tender opening stage. The Earnest Money Deposit (EMD) of the unsuccessful Firms/Junk Dealers will be discharged/returned to them without any interest only after finalization and award of the contract to the successful Firm/Junk Dealer.
- 3. Performance Security of Rs. 25,00,000/- (Rupees Twenty Five lakhs only) in the form of Demand Draft in favour of Secretary, NIOS, payable at Kolkata shall also be required to be deposited before lifting the waste materials and it shall be valid for 90 days beyond the date of completion of all the contractual obligations of the Firm/Junk Dealer. - 13. The Firm/Junk Dealer should quote their highest rates based upon the Terms and Conditions forming part of tender document. Order will be placed to the successful Firm/Junk Dealer (quoting highest rates of purchase) out of the eligible Firms/Junk Dealers.
