#### **About the Institute**

It is the largest Open Schooling System in the World. It provides education opportunities for Secondary and Senior Secondary levels and also for Vocational courses to persons who wish to study further and qualify for a better tomorrow. The mission of NIOS is to provide education to all with special concern for girls and women, rural youths, working men and women, SC,ST and divyang learners who because of one or other reason

could not continue their education with the formal system. NIOS operates through a network of Twenty two (22) Regional Centres, Two Sub-Regional Centre and two (2) NIOS Cell and about 6000 Accredited Institutions(AIs) and Accredited Vocational Institutions(AVIs) commonly known as Study Centres which are located in India, Nepal and Middle East Countries.

Addresses of NIOS Regional Centres and SRCs are attached at **Appendix-I** The annual student enrolment of NIOS at all the Regional Centres is around 5,50,000 students. It provides nine examination chances in a span of 5 years. One can take any examination during the period and can avail of credit accumulation. Enrolment in the academic year 2017-18 is expected to increase by 20 to 25% over the previous year's enrolment. #### 01 Instructions to Bidders

- i. Secretary, National Institute of Open Schooling on behalf of NIOS invites sealed tenders IN TWO BID SYSTEM (TECHNICAL AND FINANCIAL BID) from the experienced and reputed firms/agencies for pre-admission work like verification/complete checking of admission forms, Scanning of Photographs, printing and dispatch of Identity Cards and processing of pre examination work, etc., initially for a period of two years which can be extended further for a period of two more years on mutual consent on the basis of satisfactory performance of the firm. The anticipated annual business will be around Rs. 50 lakhs (Rupees fifty lakhs). per year. The tender document comprising of Technical and Financial Bid can be obtained from Section Officer(Online Admission Section) National Institute of Open Schooling, 4th Floor, Room no. 408, A-24/25, Institutional Area, Sector-62, Noida-201309 (U.P) on payment of Rs. 500/- (Rupees Five Hundred only) + GST applicable by way of a Demand Draft drawn in favour of the Secretary, NIOS payable at Noida. - ii. The proposal must to be submitted in two separate envelopes, first envelop should contain "Technical Bid" along with EMD of Rs. 2,50,000/- (Rupees Two Lakh Fifty Thousand only) and cost of the tender document of Rs. 500/- (Rupees Five Hundred only) + GST applicable in the shape of two separate Demand Drafts/Pay Orders of any Nationalized Bank in favour of the Secretary, NIOS payable at Noida and second

envelop should contain "Financial Bid" after quoting the lowest rates in the prescribed proforma appended at Annexure-II. Both the envelopes should be sealed properly and submtted in a single cover superscribed "Tender for Pre Admission Work like Verification/Complete Checking of Admission Forms, Scanning of Photographs, Printing and Dispatch of Identity Cards and Processing of Pre Examination Work, etc. The tender document shall be opened by the duly constituted Committee of NIOS in the presence of representatives of the firm/agency on the date and time specified above.

- iii. The successful tenderer shall have to submit Security Deposit/Bank Guarantee of Rs. 5,00,000/- (Rupees Five lakh only) by way of Demand Draft /Bank Guarantee drawn in favour of "Secretary, National Institute of Open Schooling, Noida" immediately after execution of the agreement as interest free security deposit for ensuring good performance and for security purposes which shall be released to the firm/agency after two months of the expiry of the contract. On receipt of security deposit, EMD of the successful tenderer shall be returned to the firm without any interest.

- vi. The firms who are doing NIOS Post examination work shall not be eligible to participate in the tender process. In case, any such firm apply for this work shall be straight way rejected. Therefore, such firm / agency is advised not to participate in the tender process.

#### 02 SCOPE OF WORK:

NIOS requires an agency who could perform the said work for all of its Regional Centres, SRCs as well as for NIOS Head Quarters. The successful agency shall have to make all arrangements at its own cost for carrying out the work of the Regional Centres, SRCs and NIOS Head Quarters as mentioned above. Job description: The successful agency shall have to perform the following jobs:

#### A. Pre-Processing Activities

Receipt of admission forms at Regional Centre(s), SRCs and NIOS Head Quarters.

(a) Firm/Agency will have to arrange receipt of admission form from Regional Centres, SRCs and NIOS Head Quarters. For this, firm/agency will have to depute its

- representatives during admission time as per directions of the concerned Officer of the NIOS.
